If a student exempts a course during one year but does not enroll in the course during the next do they lose the exempt status for the first year?

No. Each year's exemption stands alone.

hat if a student drops the exempt course?

As long as a student completes the course with a B average or better for which a GPA waiver is granted, the course will be GPA exempt. Students are expected to complete a full-year course for which a GPA exemption has been approved. In extenuating circumstances where a student is approved to drop a GPA-exempt course after the first semester is complete, the student received the first semester credit as GPA exempt. However, the remaining 0.5 GPA exemption cannot be applied to another course during second semester or following year. The requested 1.0 GPA exemption is considered to be fully expended. If a student drops a full-year course before the close of the first semester for which a GPA exemption has been approved per established guidelines [see EIA (REGULATION)], the new course the student enters is not eligible for a GPA exemption. In this case, the GPA exemption is available for use the following semester/year, if requested and approved according to established guidelines.

oes a student have to maintain enrollment in a single athletic sport to be eligible for an exemption?

No. Any athletic enrollment can qualify.

an a student take Art or Dance courses as GPA Exempt courses?

Dance Team and Dance Colorguard are the only GPA exempt courses offered. No Art courses are GPA exempt.

ho is eligible to take a course on a GPA Exempt basis?

- Students must have an overall B average in the prerequisite course for elective courses for which they are seeking a waiver.
- Students must maintain a B average in the GPA exempt course to qualify and maintain GPA exempt eligibility.
- Students must obtain approval from their parents, teachers of the course, and the counselor.
- Students may take up to three (3) credits on a GPA Exempt basis.

How do students enroll in a GPA Exempt course?

Students interested in taking one of the GPA Exempt courses must discuss this option with the counselor at the beginning of the course. If the student meets all of the criteria, they must:

- 1. Complete the GPA Exempt application, which can be found in the counselor's office.
- 2. Have the application signed by the parent and teacher.
- 3. Return the application to the counselor **no later** than the end of the third (3rd) week of each semester. At this time, if all criteria are met, it will be approved and a course change will be made to reflect enrollment in a GPA Exempt course.
- Once the student makes the decision to take a course as GPA-exempt, the decision is final and cannot be changed.
- 5. Students enrolled in full-year courses do not need to reapply during the second semester.
- 6. Students, including move-in students, who miss the deadline for application for the first semester, may apply for exemption for the second semester if they meet the criteria.

ow are grades handled in a GPA Exempt course?

Students who are eligible and choose to take one of these courses for a GPA Exempt grade:

- Will receive a numerical grade all year on the report card.
- Will receive the actual numeric grade with a comment or label indicating "GPA exempt" on the Academic Achievement Record (transcript).
- Will receive credit for these courses, but also have these courses excluded from the computation of GPA and class rank.
- Exemptions are granted on a semester basis.

hat are the performance standards for these courses?

- The numerical grade earned will be reported on the report card.
- Students must take tests and final exam for the course unless exempt from finals.
- Students must complete the extra/co-curricular components of the course.

ow will grades in a GPA Exempt course affect eligibility for extracurricular activities?

The numerical grades earned in a GPA Exempt course will be used to determine eligibility for participation in all UIL or school-sponsored activities. In addition, numerical grades will also be used to determine honor roll each six-weeks; for qualifying criteria used in selection of students for various positions such as dance team officers, class officers, exam exemptions, etc.; for eligibility for academic awards, including admission to organizations such as National Honor Society; etc.
